Please tell us about the project and why you think it should receive the contribution from Torpoint Town Council

We are Guard-Up Boxing, a father and son led not-for-profit C.I.C. We currently run Boxing for Fitness sessions in Torpoint and Millbrook.

We are both active boxers and have taken part in multiple charity boxing events, and we train regularly. Being involved in participating and organising these events, we have recognised the significant benefits on mental and physical health that the training and learning of new skills can bring.

After looking into services within our community we found that we would be able to offer something new and unique. Since our original 6 week pilot project in November/December 2023 in Torpoint, the interest for our sessions increased. When we launched officially in January 2024 we were approached by the owners of Millbrook Football Club Social Club (The Brook) to see if we could run our sessions from there too. After a successful trial of 4 weeks throughout February we now regularly run weekly sessions for the Millbrook Community. The sessions have become quite a big hit, especially with the juniors (aged 8-15yrs old)

Each session has a structured lesson plan using the Hatton Academy Boxing for Fitness platform, of which I am a certified advanced level instructor.

Currently, I am the only qualified instructor and first aider. In order for Guard–Up Boxing to progress, and enhance our current offer to reflect the increase in participants, we feel now would be the right time for my son to gain the coaching qualifications to also be a qualified instructor and first aider. This will allow larger classes and sustainability for future sessions that we offer.

Currently I am qualified at an advanced level and feel Guard-Up Boxing participants would benefit from me obtaining additional training to an elite level instructor, with additional courses focussing on instructor skills, and a separate course

specialising in coaching juniors.

Guard-Up Boxing CIC to date has been self-funded with a view to obtaining additional funding to enhance the services we offer in the future.

The training we wish to obtain is:

1st instructor additional training: Elite, Instructor skills and boxing for juniors = £280.00 2nd instructor training: Fundamentals, advanced and boxing for juniors = £399.00.

First Aid for 2nd Instructor with 'Certifi Training' = £75

Total = £754

Who will benefit from the project and how many of those are residents of Torpoint parish?

Residents of the Millbrook and Torpoint communities will benefit from the extra coaching qualifications.

We currently have 21 junior students in Millbrook, and 16 junior students in Torpoint Alongside the juniors we have 3 adult students in Millbrook, and 5 adult students in Torpoint

21 out of our 45 students are Torpoint residents
