- LGA to launch "Make a Difference, Work for your Local Council campaign" in the Autumn 2024 a comprehensive toolkit and ongoing support will be provided to all councils.
- Government consultation on proposed planning changes: The Government published a draft revised National Planning Policy Framework (NPPF) on 30 July 2024 as part of the planning changes consultation. The consultation runs until 24 September 2024 and proposes numerous changes, including an increase in housing numbers requirements. To help with understanding what this means for Cornwall, Cornwall Council's Policy Team have produced this briefing note to help local councils with their individual responses. Cornwall Council will also be providing an update on this at the next local council planning training on 19 September.
- NALC has updated its HR policies including how-to-guides, a template contract of
  employment and The Good Councillors Guide to Employment. Local councils are encouraged to
  adapt these templates based on their specific needs and should ensure their policies align with their

• ACRE Village Hall Building Grants: ACRE has recently confirmed that village hall management committees can once again apply for grants of up to £75,000 to improve village hall buildings. The

fund, which was originally announced to mark the Late Queen's Platinum Jubilee has reopened for new applications. Groups can submit applications for grants of between £7,500 and £75,000, which can be used to cover up to 20% of capital costs associated with renovation and improvement projects. This latest window for new applications is expected to last until government funding has been exhausted. The application process is competitive, and hall committees must be able to complete the project work by the end of March 2025. Current projections suggests all funding will be allocated by February 2025 and funding will not be available in future years.
