Our lead arboricultural officer has reviewed this and he has had confirmation that works the ash tree have been completed to the extent that all deadwood within the crown has been removed. It was never the specification to remove the tree in its entirety, but by removing the dead wood, which by the nature of the ash tree in question becomes brittle and falls out, this should no longer happen.
